They are eligible to sign up as regular attendees at the same Individual Registration rates on the Registration page at www.loma.org/preneed.

LIC Conferences such as the Preneed Forum are mid-sized meetings drawing a diverse and relatively large audience of 30-50 attendees, and they focus on a specific product area – in this case Preneed. They include a mix of presentations and facilitated audience discussion. This is a great opportunity for your company to show a strong commitment to the industry and gain visibility among LIC’s small-to-midsize life insurance companies.

Benefits of Sponsoring the 2020 LIC Preneed Forum

The 2020 LIC Preneed Forum is going to be held virtually via Webex over a two-day period, November 18 and 19, 2020. Your sponsorship includes:

- One fully participating attendee (additional registrations can be purchased).
- A slide with your photo and logo near the beginning of the Attendee Introductions Session, with an introduction to the audience and a minute to briefly describe your company’s value proposition for LIC attendees.
