How to Apply for Credit for the ACS P&C Track

1. Register as a LOMA student and enroll for ACS 100 or ACS 101.
2. Download and print a copy of the application form.
3. Check the boxes next to the courses for which you want to receive credit.

Note:

To earn the ACS designation in the P&C track, you must pass ACS 100 or ACS 101 and obtain credit for four of the courses listed on this form. Two courses are required; two are elective. Please consult www.loma.org for more information.

Note:

The CPCU designation provides credit for courses AINS 21, AINS 22, and AINS 23.

4. Fill in all the contact information in the spaces provided.
5. Attach an official transcript or other verifiable document from the sponsoring organization of each course you are applying for credit. Acceptable documentation includes a printout of your course history, a copy of your grade report, or a copy of your diploma. LOMA reserves the right to contact the sponsoring organization to confirm your award.
